***Please note:** It is ScreeningOne's standard operating procedure to verify any aliases revealed in a Social Security Trace by conducting a National Criminal Search on each alias. If preferable, a set maximum can be established (2, 3, etc.). This search will be charged at a discounted rate of \$3.00 per alias. A paid trial period is available upon request for a one month period.
