CHAMPS Spanish Language Training for Health Care Professionals



CHAMPS and the Denver Medical Society (DMS) hosted the annual Spanish Language Training for Health Care Professionals April 21-24, 2017, in Denver, CO. Thirty-six participants were immersed in four full days of medical Spanish language training in two separate classes, one for beginners and another for more advanced students. The training was attended by staff members from 11 different Community Health Centers and several private practices. Participants reported that the “very energetic and approachable instructors,” “practicing scenarios with classmates,” and “information about Latin culture” were the best aspects of the training. CHAMPS plans to offer the training again in spring 2018.

November 16, 2017 Deadline for Implementing New CMS Emergency Preparedness Regulations

The Centers for Medicare and Medicaid Services (CMS) final rule [Emergency Preparedness Requirements for Medicare and Medicaid Participating Providers and Suppliers](#) went into effect on November 16, 2016. All health care providers and suppliers affected by the rule, including health centers, **must implement all regulations by November 16, 2017**. The CMS rule includes four core elements: emergency plan, policies and procedures, communication plan, and a training and testing program.

Information Therapy to Improve Patient Health Literacy

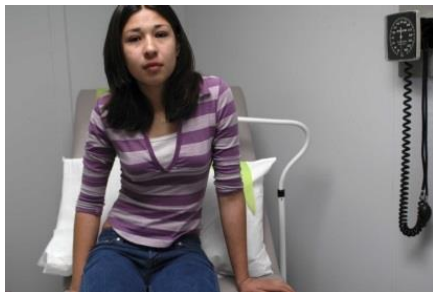

Providing patients with the right information, at the right time, in the right format can be a challenge. But research has shown that introducing health information at the appropriate time in the healthcare continuum increases clinician-patient communication, patient adherence, and patient motivation to improve health behaviors. The National Library of Medicine (NLM) has developed numerous free online databases for patient and consumer education, including MedlinePlus, PubMed Health, DailyMed, and LactMed. Two-Dose HPV Vaccination Series Now Recommended for Adolescents

The Centers for Disease Control and Prevention (CDC) recently revised recommendations for the HPV (human papillomavirus) vaccination series. For children ages 9 to 14, two doses instead of three are now recommended; the two shots should be administered at least six months apart. The CDC continues to recommend that most children get the vaccine at age 11 or 12

because the vaccine causes a better immune response in children than in teens. Teens and young adults who receive the vaccination at ages 15 to 26 will continue to need three doses of HPV vaccine. Children and teens ages 9 to 14 who have already received two doses of HPV vaccine less than six months apart will require a third dose. Three doses are also recommended for people with weakened immune systems ages 9 to 26.

Most cervical cancers are caused by HPV, as are several other types of cancer. It is not often that we have an opportunity to prevent cancer, or in this case multiple cancers, with a single tool. Because physician recommendation is the strongest predictor of receipt of vaccination, HPV vaccination offers opportunities for FQHCs to focus on cancer prevention with their adolescents and families.

The American Cancer Society has several resources available to help raise vaccination rates, including [Quality Improvement Partnership](#) opportunities and the [National HPV Vaccination Roundtable](#). Activities are underway at the state and local levels in Colorado, Utah, Wyoming, North Dakota, and Montana to help health care professionals, parents, and public health professionals increase HPV vaccination rates. 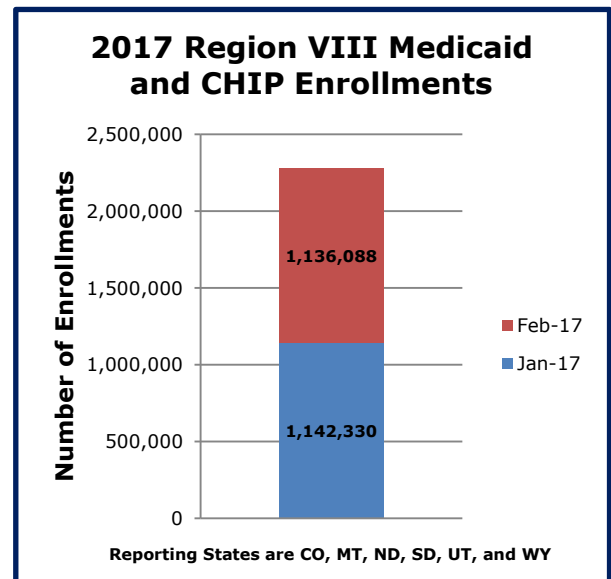
CHAMPS/CCHN 2017 Distance Learning Series

Medicaid and CHIP Enrollment Data Highlights

This month [Medicare.gov](#) released the February 2017 Medicaid and Children's Health Insurance Program (CHIP) Enrollment Data Highlights report comparing all 50 states and the District of Columbia's Medicaid and CHIP agency enrollments for the month of February. The report is one of a series on state Medicaid and CHIP data. The graph to the right shows the number of Medicaid and CHIP enrollments in January compared to February 2017 in Region VIII states (CO, MT, ND, SD, UT, and WY). The data shows that from January to February 2017 the number of enrollments declined by 6,242. This decrease can likely be explained by the closing of Open Enrollment Period 4 (OEP4) on January 31 for five of the Region VIII states (MT, ND, SD, UT, and WY) and on February 3 for Colorado. After these dates, enrollments in Medicaid and CHIP programs continued only for those eligible for a special enrollment period through a qualifying life event.

Trust for America's Health Releases Brief on Impact of Health Reform Proposals

In March, Trust for America's Health published a brief titled "Impact of the 2017 Health Reform Proposals on Clinical Preventative Services," which reviews the current state of healthcare coverage for preventative services and what is at stake if this coverage is eliminated or reduced. According to the brief, a range of legislative and administrative actions could potentially lead to millions of Americans losing access to preventative services, either through reductions or changes in requirements or as part of losing healthcare coverage. The brief also details the positive health outcomes that result from coverage of preventative services, including increased rates of routine exams and screenings, reduced risk of developing type-2 diabetes, reduced premature birth and infant mortality rates, increased vaccination rates, and medical savings.

CMS Issues Final Rule to Increase Choices and Encourage Stability in Health Insurance Market for 2018

On April 13, 2017 the Centers for Medicare and Medicaid Services (CMS) issued the final Marketplace Stabilization rule to help lower premiums, stabilize individual and small group markets, and increase choices for Americans. The rule makes the following changes:

- ★ **2018 Open Enrollment Period:** November 1-December 15, 2017.
- ★ **Verification of Special Enrollment Eligibility:** Individuals applying for health insurance coverage during a special enrollment period will have to provide supporting documents to prove their eligibility.
- ★ **Promote Continuous Coverage:** Issuers will be allowed to require individuals to pay past due premiums before enrolling into a plan with the same issuer the following year.
- ★ **Ensure More Choices for Consumers:** Issuers will have additional actuarial value flexibility to develop more choices with lower premium options for consumers.
- ★ **Empower States and Reduce Duplication:** The oversight of network adequacy will be given to states from the federal government, in an effort to reduce duplication.

Robert Wood Johnson Foundation's 2017 County Health Rankings and Roadmaps



In April the Robert Wood Johnson Foundation, the nation's largest philanthropy organization dedicated solely to health, released the 2017 County Health Rankings and Roadmaps. The rankings allow users to view the status of their county's health in relation to surrounding counties within the same state, while the roadmaps tool lays out a series of steps to help foster improvements in community health. Users can explore each of the seven steps – Work Together, Assess, Focus, Choose, Act, Evaluate, and Communicate – to plan community health improvements and to access additional action tools.

Morbidity and Mortality Weekly Report Rural Health Series

In January 2017, the Centers for Disease Control and Prevention (CDC) began publishing one to two Morbidity and Mortality Weekly Reports (MMWRs) per month on topics related to rural health disparities. The reports compare urban and rural communities in terms of potentially excess deaths; health-related behaviors; mental, behavioral, and developmental disorders in children; and diabetes self-management education. In April, the Journal of Rural Health published a response to one of the reports praising the authors' arguments and recommending steps to build on their work. The Rural Health Information Hub (RHIhub) is also conducting a series of webinars focusing on key points from these MMWR Rural Health Series reports.

Ag Worker Access 2020 Campaign

On May 22, 2015, the National Association of Community Health Centers (NACHC) and the National Center for Farmworker Health, Inc. (NCFH) announced the Ag Worker Access 2020 Campaign. This call to action arose out of the 2015 National Farmworker Health Conference, where over 250 health center executives, consumer board members, clinical leaders, and farmworker advocates agreed to work collaboratively to increase access to care for migrant and seasonal agricultural workers and their families over the next five years (2015-2020). At the time of the conference, only 18 percent of agricultural workers in the U.S. were being served by health centers.

The Ag Worker 2020 Campaign calls on every migrant health center grantee to increase the number of agricultural workers served by 15 percent each year until 2020. The campaign also asks health centers that do not receive Migrant Health Funding (330g) to report all of their patients who meet the definition of “migrant” or “seasonal” agricultural worker per Uniform Data System (UDS) criteria.

The Ag Worker 2020 Campaign has many social media, presentation slides, and printable and digital resources available on their website. Webinars and phone consultations are also available to health centers that need additional information or guidance on how to reach migrant and seasonal agricultural workers in their communities.

Technical Assistance Partners Collaborate on Colorado Team-Based Care Initiative

In September 2015, Technical Assistance partners John Snow, Inc. (JSI), Colorado Community Health Network (CCHN), Leibig-Shepherd, LLC, and Kaiser Foundation Research Institute (formerly MacColl Center for Healthcare Innovation) began working together to assist a collaborative of 19 safety net practices, both rural and urban, to transform to a team-based care model. The practices include Federally Qualified Health Centers (FQHCs), residencies, small private practices, pediatric clinics, and school-based health centers. Funded by the Colorado Health Foundation, this three-year initiative is designed to help primary care practices throughout Colorado optimize existing care teams to deliver coordinated, high-quality care by working collaboratively with patients to accomplish shared goals. The goal of this initiative is for practices to be better prepared for further transformation, as well as for anticipated payment reform holding them more accountable for the health outcomes of their patients.
