2023 Abbreviated Salary Survey Data Collection Complete

Every two years, CHAMPS undertakes a large Salary, Benefits, Turnover, and Vacancy Survey of all health centers within Region VIII. For the first time, CHAMPS is using the "off" year to gather information about a limited group of hard-to-recruit/retain titles via the 2023 Abbreviated Salary, Benefits, and Turnover Survey. Data collection for this 2023 survey occurred mid-March through mid-May, and CHAMPS and Colorado Community Health Network (CCHN) staff are working to clean and analyze the data received. Reports will be distributed beginning in autumn 2023. CHAMPS would like to sincerely thank all the Region VIII health centers that submitted data, and specifically the staff members who gave so generously of their time while working on this project!

2022 Clinical Staffing and Provider Productivity Expectations Reports

The last two companion reports related to data submitted during the 2022 Region VIII Health Center Salary, Benefits, Turnover, and Vacancy Survey project were released in April 2023. The Region VIII Health Center Clinical Staffing Report utilizes Full-Time Equivalents (FTEs) data reported in the salary survey for every employee at each reporting health center to develop staffing ratios relating to medical, behavioral health, and dental providers and medical and dental support employees as well as ratios related to additional selected administrative and clinical care team employees. The Provider Productivity Expectations Report includes information about health center expectations for weekly hours, administrative vs. patient contact hours, completed hourly visits, and standard patient panel sizes for medical, dental, and behavioral health providers. Both reports can be accessed by CHAMPS Organizational Members in the Members Only section of the CHAMPS website (username and password required). Nonprofit, non-member organizations are welcome to purchase electronic versions of these reports by completing this order form and returning it with payment to CHAMPS.

On March 30, 2023, CHAMPS hosted the Understanding and Utilizing Statistics from the CHAMPS 2022 Salary Survey Project webinar, which explained the history and methodology of the survey, highlighted key changes from prior years, and reviewed the contents and structure of the resulting reports. The presenter also addressed identified trends in salaries and benefits, workforce metrics including vacancies, turnover, and challenging areas of recruitment and retention, and additional data relating to provider vs. support staffing ratios and provider productivity expectations.

2023 CORE Competencies Training Highlights

The CHAMPS 2023 CORE Competencies for Health Center Supervisors and Managers Training took place virtually in March and April 2023. CHAMPS hosted this five-week training with support from Association for Utah Community Health (AUCH), Colorado Community Health Network (CCHN), Montana Primary Care Association (MPCA), and Wyoming Primary Care Association (WYPCA), bringing together 45 participants from 16 health centers to learn best practices for hiring, training, developing, engaging, and retaining health center staff. In addition to weekly sessions, participants



undertook homework assignments to implement their learning in their health centers. Evaluators reported the lead facilitator, Lisa Mouscher, the peer learning, and the immediately useable exercises and tools as some of their favorite aspects of the course.

UpSkill NIMAA

The National Institute for Medical Assistant Advancement (NIMAA) offers valuable continuing education through UpSkill NIMAA. The courses cover a variety of topics, such as Interprofessional Team-Based Care, Professionalism, Health Coaching, and Quality Improvement. Due to popular demand, NIMAA will also offer a 20-hour Certification Exam Review course:



- ★ In conjunction with partners at McGraw Hill, NIMAA provides resources, materials, and best practices to prepare course participants to successfully pass their preferred medical assisting credentialing exam.
- ★ Exam preparation and materials are available for the following exam options:
 - The Registered Medical Assistant (RMA) exam created by the American Medical Technologists:
 - o The Certified Medical Assistant (CMA) exam credentialed by the American Association of Medical Assistants, and
 - The Certified Clinical Medical Assistant (CCMA) exam approved by the National Healthcareer Association.
- ★ In addition to exam preparation, the program provides information to help participants decide which exam to choose.
- ★ The course includes eight online didactic sessions plus eight live review sessions with a NIMAA instructor.
- ★ Participants gain an understanding of the various credentialing exams and significant practice answering sample exam questions that reflect common content and formats.

CHAMPS/DMS Spanish Language Training Highlights

CHAMPS and the Denver Medical Society (DMS) recently hosted several online Spanish Language Classes and Tutorials for Health Care Professionals. Throughout April 2023, CHAMPS held four different Spanish language trainings, including three two-day courses: 16 participants joined the Spanish Language for Oral Health Providers offering, three attended the Spanish Language for Behavioral Health Providers training, and 11 joined the Medical Spanish for Advanced Speakers sessions. Twenty-five learners joined the traditional four-day course that CHAMPS has held for over 30 years, ranging from beginner to intermediate skill levels. Each of the courses contained content related to medical diagnosis, and included roleplays, visual aids, and cross-cultural diagnosis. Attendees also engaged in discussions on cultural humility and awareness. Participants reported that the immersive and joyful teaching style, conversations and discussions, practice scenarios, and the opportunity to get to know other Region VIII health center staff were the best aspects of the training. CHAMPS plans to offer these trainings again in Spring 2024.

Coming Soon: CHAMPS On Demand 2023 Immunization Update

CHAMPS will host the annual Immunization Update with Dr. Patricia Wodi and Dr. Neil Murthy, both Public Health Physicians from the National Center for Immunization and Respiratory Diseases at the Centers for Disease Control and Prevention (CDC). This one-hour module will address the latest vaccine schedules and the most recent Advisory Committee on Immunization Practices (ACIP) recommendations for adults, children, and adolescents, including the latest COVID-19 vaccine recommendations for all populations. This year the training will be pre-recorded and available on-demand. Continuing Medical Education (CME) credits have been applied for. Taught by Rios Associates, the instructors for the very popular CHAMPS Spanish Language Intensives, Speak My Culture was a two-part virtual series that allowed healthcare workers to better understand the challenges facing the Latino patient community and to obtain ideas, tools, and strategies to prepare them to offer culturally appropriate and sensitive care to their Latinos patients. The first session focused on diabetes care, while the second session addressed other health care topics including mental health, maternal health, and vaccines. 2023 NACHC Conference For Agricultural Worker Health

The National Association of Community Health Centers (NACHC) Conference for Agricultural Worker Health, the only national conference solely dedicated to improving health for Migrant and Seasonal Agricultural Workers and their communities, was held in Seattle, WA from May 2-4, 2023. This year's

theme was "Sowing Strength/Cultivando Fortaleza: Meeting Environmental, Social and Care Challenges in Farmworker Health." The event brought together leaders in migrant health to collaborate and discuss ways to increase the well-being of migratory and seasonal agricultural workers and their families while providing educational and networking sessions for attendees.



2023 National Health Care For The Homeless Conference and **Policy Symposium**

NATIONAL HEALTH CARE for the HOMELESS COUNCIL

Each year, the National Health Care for the Homeless Council hosts the largest convention of homeless health care practitioners, advocates, people who have experienced homelessness, and researchers specializing in homelessness. The 2023 Conference took place in Baltimore, MD from May 15-18. The theme, "Toward Justice: Leading with Lived Experience," highlights the increase in inequities and criminalization of homeless, and the negative impact it has on our society as well as the individuals with direct lived experiences.

Medicaid Unwinding

Medicaid and Children's Health Insurance Program's (CHIP) continuous coverage protection ended on Friday, March 31, 2023 due to the new FY2023 Omnibus Bill. On April 1, 2023, states began to terminate coverage for individuals who are no longer eligible. However, they must allow at least 60 days between the initiation of redetermination and disenrollment, therefore states began conducting redetermination of eligibility as early as February 1, 2023. The Centers for Medicare and Medicaid Services (CMS) released quidance for states' unwinding efforts and will be hosting meetings with each state to discuss plans and answer questions. Health centers should encourage Medicaid patients to confirm that the state has their current contact information to ensure they receive information about their eligibility and avoid losing coverage for administrative reasons. Additionally, CMS has provided guidance to state Medicaid agencies about how 1115 waivers can be used to direct Medicaid funding to social determinants of health (SDOH) spending.

Community Partnerships to Address Structural Vulnerabilities

Efforts made by health centers to advance health equity must include an analysis of the structural factors and social, economic, and political systems that impact the health and quality of life of their patients and communities. However, the prospect of dismantling such large and deeply rooted institutions at times may feel daunting to approach. Health Outreach Partners is holding a webinar that will introduce participants to the Structural Competency framework, demonstrate the impact of "Structural Interventions," whether big or small, and emphasize the importance of engaging partners in this effort. By taking steps to address these structures, health centers not only can improve health disparities of their existing patient population but work to reduce the impact of these disparities for the next generation and the community as a whole. End of Public Health Emergency

The Federal COVID-19 Public Health Emergency (PHE) ended on May 11, 2023. It is important to note several changes will impact COVID-19 care. The COVID-19 at-home test kits may no longer be covered by insurance, Centers for Disease Control and Prevention (CDC) reporting metrics may change, and vaccines and treatment for COVID-19, such as Paxlovid, will remain available for free, while supplies last. The CDC's No-Cost COVID-19 Testing locator may help individuals find current community and pharmacy partners participating in the Increasing Community Access to Testing (ICATT) program.

FDA Update to EUA for Monovalent Vaccines

On April 18, 2023, the <u>U.S. Food and Drug Administration</u> (FDA) amended the emergency use authorizations (EUAs) of the Moderna and Pfizer-BioNTech COVID-19 bivalent mRNA vaccines. The monovalent Moderna and Pfizer-BioNTech COVID-19 vaccines are no longer certified for use in the U.S. The FDA allowed bivalent mRNA vaccines for all doses administered to individuals aged six months and older as a simplification for vaccination scheduling. Additionally, on April 19, 2023, the Centers for <u>Disease Control and Prevention</u> (CDC) <u>authorized</u> an additional updated booster dose for adults ages 65 years and older and additional doses for people who are immunocompromised.

HRSA Funds Teaching Health Center Planning and Development Program

On March 31, 2023, the U.S. Department of Health and Human Services (HHS), through the Health Resources and Services Administration (HRSA), granted nearly \$23 million to 46 recipients to assist in the planning and development of Teaching Health Center residency programs. Two of these awardees are Region VIII health centers, Community Health Centers, Inc. in West Valley City, UT and Community Health Care Center, Inc. in Great Falls, MT. Teaching Health Center programs prioritize improving care in community-based outpatient settings.

HRSA Seeks Volunteers for UDS+ Pilots

In early May, the Health Resources and Services Administration (HRSA) announced that 2023 Uniform Data System (UDS) reporting would be submitted in the traditional method, via HRSA's Electronic Handbooks (EHBs). UDS+, the UDS Modernization Initiative aimed at reducing reporting burden, improving data quality, and better measuring program services and outcomes through reporting patientlevel data, will be delayed. However, HRSA is seeking health centers, Primary Care Associations (PCAs), and Health Center Controlled Networks (HCCNS) to participate in UDS Test Cooperative (UTC) pilots to test and offer feedback on proposed UDS+ changes and enhancements.

News From the Geiger Gibson Program in Community Health

In April, the Geiger Gibson Program released Federal Grants are Essential to Community Health Centers, a data note highlighting the importance of health centers in the primary health care system as they treat medically underserved communities and populations. This Uniform Data System (UDS)-informed publication examines the role of federal grants and how these funds support health center services.

An Oral Health Crisis: Identifying and Addressing Health Disparities

On March 29, 2023, the U.S. Senate Committee on Finance's Subcommittee on Health Care held a hearing regarding the Oral Health Crisis in the U.S. Jonathan Forte, MHA, FACHE, President and CEO at RiverStone Health in Billings, MT, testified to the importance of investing in health centers so they may better serve oral needs, expressing a belief that "equitable access to oral health care is not simply a rural problem, or an urban problem, it's an American problem impacting families no matter where they live."



He provided examples of how America's health centers develop collaborative partnerships and "serve as centers of innovation for workforce development," the ways Congress can support and incentivize "fully integrated and equitable models for oral health delivery," and how by expanding mobile health providers can see more patients regardless of proximity to health centers. It is difficult to recruit and retain oral health care professionals in Montana, so RiverStone Health has partnered with accredited dental schools to educate students and the Montana Primary Care Association (MPCA) to provide scholarships for dental assistants and other individuals interested in completing the program after committing to employment. Additionally, he discussed the impact of interdisciplinary teams and how they increase efficiency, improving cost-effectiveness and health outcomes, giving patients holistic care as well as dental support.

In 2023, the Health Resources and Services Administration (HRSA) updated the Site Visit Protocol (SVP) to increase consistency, solidify formatting, and incorporate simple language. The SVP was designed by HRSA to collect necessary information to maintain oversight over health centers. These changes do not alter the way site visits are conducted, but instead make the SVP easier to read. In addition, the edits include one substantive change to correspond with Calendar Year 2024 Requirements for Federal Tort Claims Act (FTCA) Coverage for Health Centers and Their Covered Individuals (hrsa.gov).

Horizon Health Care Recognized as a Partner in Health

Horizon Health Care, Inc. received the Partner in Health Award from the South Dakota Department of Health for their role in improving access to public health and community well-being in the rural areas of South Dakota. Horizon Health Care was recognized for their family planning services, which include pregnancy testing, education, screening, and counseling. The objective of these programs is to provide patients with individualized care while they begin building their family.

HRSA Training: Community-Based Grant Programs

The Health Resources and Services Administration (HRSA) Regional Office has developed a training session about HRSA community-based grant programs. The intent is to familiarize attendees with HRSA grant programs for which community-based organizations are eligible to apply, and includes purpose of the grant program, amount and duration of grant funding, approximate Notice of Funding Opportunity (NOFO) release dates, and core elements and key requirements to address in the grant application. The training may be held virtually or in person and lasts 45-90 minutes depending on the number of grant programs covered. The training covers grants from the following HRSA Bureaus/Offices: Federal Office of Rural Health Policy, Maternal and Child Health Bureau, Bureau of Health Workforce, and Bureau of HIV/AIDS.
