2022 Fall Primary Care Conference Educational Session Highlights

The upcoming CHAMPS/NWRPCA Fall Primary Care Conference will feature 46 in-person and 10 virtual educational sessions across nine tracks, including:

Clinical and Care Innovations: Didactic and interactive sessions related to historical trauma, compassion fatigue and burnout, un-silo opioid disorder treatment, cancer screening, quality improvement, and more.

Fiscal Optimization: Sessions addressing financial health and growth, including capital development, accounting and auditing, valuebased data, extending health center services. health-center specific compensation data, etc.

Governance Essentials: An introduction to the Health Center Movement as well as sessions addressing diversity, equity, inclusion, and belonging, strategic planning, requirements, roles, and responsibilities, and more.

Healthy Communities: Offerings to assist health centers with transforming the health system for formerly incarcerated individuals, safe firearm storage, health equity for LGBTQ+ populations, and increasing self-efficacy among community health workers.

Hot Topics: Emerging topics impacting health centers; sessions will be finalized closer to the conference.

HR/Workforce: Interactive sessions featuring tools and strategies addressing culture and employee wellness, integrating community health workers, first steps to implementing a workforce development program, partnerships to build equity, and trauma informed care.

Leadership: Sessions focusing on implicit and unconscious bias, cultivating a coaching mindset, change management, and more.

Operational Excellence: Sessions addressing care team incentive programs, cybersecurity and privacy, compliant 340B drug pricing programs, how to manage priorities with low staffing, utilizing renewable energy for resilience and cost-savings, emergency preparedness lessons learned, and CMS regulations.

Policy: Experts addressing current national and state-based issues and priorities.

2021 Region VIII UDS Information

In 2021, Region VIII Health Center Program Grantees served almost 1,090,00 patients, provided over 4,200,000 visits, and employed over 10,200 Full-Time Equivalent employees.

Each year CHAMPS compiles a summary of Region VIII Bureau of Primary Health Care (BPHC) Uniform Data System (UDS) information, focusing on data relating to grantees, sites, staffing, visits, income, and patients, as well as trends for medical, dental, and mental/behavioral health productivity, factors impacting financial trends, and performance for a variety of clinical measures. The full 2021 Region VIII UDS Summary as well as a two-page 2021 Region VIII UDS Fact Sheet will be released soon.

CHAMPS 2022 Next Level Skills Training Begins September 1



Registration is now closed for the CHAMPS 2022 Beyond CORE Competencies: Next Level Skills for Health Center Supervisors and Managers intensive course, to be held online over six Thursday mornings from September 1 to October 6, 2022. Facilitator Lisa Mouscher of Sogence Training and Consulting will welcome 50 participants from all six Region VIII states with a review of the crucial skills needed to hire, coach, retain, and manage others. The

group will then delve deeper into the best practices, knowledge, and skills needed to be a great manager including effectively engaging a diverse workforce, avoiding, circumventing, and de-escalating conflict, strengthening day-to-day decision-making practices, and successfully managing change. Periodic and guided homework assignments will ensure attendees can put their new skills into immediate action.

2022 CHAMPS Salary Survey Data Analysis Underway

Data collection took place throughout the spring and early summer of 2022, and CHAMPS staff are working to analyze the data received. Reports of aggregated data will be distributed beginning in October/November 2022. CHAMPS would like to sincerely thank the Advisory Committee of Region VIII health center and Primary Care Association (PCA) representatives that provided expertise to guide this year's project, the 50 Region VIII health centers that submitted data for over 9,100 employees, and our partners at Colorado Community Health Network (CCHN) for their help on this project.

Update on Pediatric COVID-19 Vaccines

On June 18, 2022, the Centers for Disease Control and Prevention (CDC) Director Rochelle P. Walensky, MD, MPH, endorsed the Advisory Committee on Immunization Practices' (ACIP) recommendation that all children six months through five years of age should receive a COVID-19 vaccine. This authorization expands eligibility for vaccination to nearly 20 million additional children and means that all Americans ages six months and older are now eligible for vaccinations. Parents and caregivers can now obtain Pfizer-BioNTech or Moderna vaccines for their children six months through five years. All children, including children who have already had COVID-19, should get vaccinated.

FDA Issues COVID-19 Related Emergency Use Authorizations

On July 6, 2022, the U.S. Food and Drug Administration (FDA) revised the Emergency Use Authorization (EUA) for Paxlovid (nirmatrelvir and ritonavir), to authorize state-licensed pharmacists to prescribe Paxlovid to eligible patients, with certain limitations to ensure appropriate patient assessment and prescribing of the medication.

Alongside this, on July 13, 2022, the FDA issued an EUA for the Novavax COVID-19 Vaccine, Adjuvanted for the prevention of COVID-19 caused by severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) in individuals 18 years of age and older. Six days later, the Centers for Disease Control and Prevention's (CDC) recommendation followed the FDA's authorization of the Novavax COVID-19 vaccine for emergency use in individuals 18 years and older as a primary vaccination series against COVID-19, and an Advisory Community on Immunization Practices' (ACIP's) recommendation for use of this vaccine.

Total Confirmed U.S. Cases of Monkeypox/Orthopoxvirus as of August 18, 2022: 14,115

Monkeypox is a rare disease caused by infection with the Monkeypox virus, which is part of the same family of viruses as variola virus, the virus that causes smallpox. Its symptoms are similar to smallpox symptoms, but milder and rarely fatal. Monkeypox is not related to chickenpox. Symptoms may include a rash located on or near the genitals or anus and on other areas like the hands, feet, chest, face, or mouth. Other symptoms of monkeypox can include fever, chills, swollen lymph nodes, exhaustion, muscle aches and backache, headache, and respiratory symptoms (e.g., sore throat, nasal congestion, or cough). The virus is spreading mainly through close, intimate contact with someone who has Monkeypox. The Centers for Disease Control and Prevention (CDC) recommends vaccination for people who have been exposed to Monkeypox and people who are at higher risk of being exposed. The CDC is urging healthcare providers in the U.S. to be alert for patients who have rash illnesses consistent with Monkeypox.

Recent Funding for Health Centers in Region VIII and Nationwide

HHS Awards New and Existing Teaching Health Centers: In early July 2022, the U.S. Department of Health and Human Services (HHS) awarded approximately \$155 million to 72 teaching health centers, to support primary medical care and dental residency programs in underserved and rural communities. Awards included funding for new resident positions within existing and new teaching health centers and to support training in Teaching Health Center Graduate Medical Education residency programs. Region VIII's RiverStone Health (MT) was awarded funding for their Montana Family Medicine Residency program.

Phase 1 Winners of the Racial Equity in Postpartum Care Challenge: In late July 2022 HHS announced 25 Phase 1 winners in the Racial Equity in Postpartum Care Challenge, sponsored by HHS Office of Women's Health and the Centers for Medicare and Medicaid Services (CMS) to improve equity in postpartum care for Black or African American and American Indian/Alaska Native (AI/AN) women enrolled in Medicaid or the Children's Health Insurance Program (CHIP). The Region VIII Phase 1 winner, One Health (MT), offers a program that utilizes American Indian peer support specialists to connect families with individualized services.

Rural Residency Planning and Development Funds: In early August 2022, as one component of nearly \$60 million in investments to grow the health workforce and increase access to quality health care in rural communities, the Federal Office of Rural Health Policy (FORHP) announced nearly \$10 million in funding to support 13 organizations establish new medical residency programs to increase the number of physicians training in rural settings. Region VIII's RiverStone Health (MT) was awarded funding for their Montana Family Medicine Residency program.

Funding to Advance Health Equity through Better Data: In early August 2022, HHS awarded nearly \$90 million to nearly 1,400 community health centers across the nation to support and advance health equity through better data collection and reporting, which includes data modernization, identification and response to specific needs to patients and communities, further the COVID-19 response, mitigation, and recovery efforts, and more. Forty-three Region VIII health centers received these UDS+ Awards, funded through the American Rescue Plan (ARP) Act.

Three Region VIII PCAs Receive HCCN Awards

In July 2022 three Region VIII State Primary Care Associations (SPCAs) received Fiscal Year 2022 Health Center Controlled Networks (HCCN) Awards, including Montana Primary Care Association (MPCA), Community HealthCare Associations of the Dakotas (CHAD), and Association for Utah Community Health (AUCH). Colorado Community Managed Care Network (CCMCN) also received funding. These awards support the ability of HCCNs to strengthen and leverage health information technology (HIT), improving health center operational and clinical practices and resulting in better outcomes in communities they serve.

Explore State and National 2021 UDS Data

State and national Bureau of Primary Health Care (BPHC) Uniform Data System (UDS) figures for 2021 were released in early August. Each year, Health Center Program awardees and look-alikes are required to report a core set of information, including data on patient characteristics, services provided, clinical processes and health outcomes, patients' use of services, staffing, costs, and revenues as part of a standardized reporting system. CHAMPS compiles this information from across Region VIII to create a regional summarized history of UDS information, providing two, three, and five year trends of selected Region VIII and national data, plus breakdowns of data by state, Region VIII, and nation for the current year. A two-page 2021 Region VIII Health Center Fact Sheet and full 2021 Region VIII BPHC UDS Summary will be released by CHAMPS soon.
